NOTICE OF APPEAL

Pursuant to 43 C.F.R. §§ 4.410 and 4.411 and 30 C.F.R. §§ 290.2 and 290.4, Hilcorp Alaska, LLC (“Hilcorp”) hereby notices its appeal of the Bureau of Safety and Environmental Enforcement’s (“BSEE”), December 26, 2024 denial (“Denial”) of Hilcorp’s August 28, 2024, request for suspension of production (“SOP”) for three Alaska Outer Continental Shelf (“OCS”) leases— OCS-Y-1585, OCS-Y-1650, and OCS-Y-1886 (together the “Liberty Unit”)—and the BSEE Notice of Lease Expiration and Liberty Unit Termination (“Notice”) dated January 21, 2025.¹


This appeal is timely submitted to BSEE within 60 days of the Denial and Notice in accordance with 30 C.F.R. § 290.4. Pursuant to the requirements of 30 C.F.R. § 290.4, attached are copies of the Denial (Attachment A), the Notice (Attachment B), and a *Pay.gov* confirmation receipt page reflecting payment of a processing fee for this appeal (Attachment C).

¹ The Denial was signed by the Biden Administration’s Acting Deputy Secretary but states that “BSEE is informing Hilcorp that our review of the SOP request is complete, and BSEE is issuing a decision on the request as detailed in this letter.” BSEE’s decision does not indicate that it is a final agency action of the Department of the Interior.

Hilcorp reserves the right to supplement this Notice of Appeal with a Statement of Reasons in accordance with 43 C.F.R. § 4.412.
