Been out and about with some folks and will be gone again today to 4-FRI, but wanted to respond: First of all, any time we have met with the OHV Club to discuss issues relating to the commercial aspects of their event, we come away with a tightening of the Club's intentions to be outside of any permit guidelines; they are "honing" their responses based on the critical issues being called into question. The Club readily admit mistakes in the website and in the printed material - there are several references relating to 2011 instead of 2012 in the Jamboree publication. The group has apologized for not having all material up to date and for not being proficient in web design, nor clean content. As such I do believe the club is serious about separating their activities from national forest lands – they are struggling "to say what they mean". We made it plain that all cross-country travel is prohibited within the Wallow fire area, with two exceptions - woodcutting and big game retrieval. Only roads and trails identified through the "white arrow" system are currently open - no exceptions, we are currently using a July 2012 map showing those open roads and trails. We will have folks out on patrol and monitoring to assure no commercial use is occurring. We will cite individual offenders, organizers, or both if see violations have taken place. We will be working with FS law enforcement and other agencies for compliance issues.
