Re: Oppose the Nomination of Stevan Pearce as Bureau of Land Management Director

Dear Chairman Lee, Ranking Member Heinrich,

On behalf of our 81 organizations and millions of members and supporters, we urge you to oppose the nomination of Stevan Pearce to be the Director of the Bureau of Land Management (BLM). Mr. Pearce has based his political career in absolute disdain for the 245 million acres of public lands he has now been nominated to administer. If confirmed, Mr. Pearce will severely undermine protections for recreation and cultural resources, air and water, and the nation's most imperiled wildlife—if he does not seek to outright sell off our shared natural heritage first.

We urge you to oppose confirming Steve Pearce because he:

Supports Liquidating Public Lands

Mr. Pearce is fundamentally opposed to the existence of public lands and therefore cannot be entrusted with their stewardship. As a sitting congressman, his anti-public lands sentiments were increasingly made plain. In 2012, he publicly professed his desire to “reverse this trend of public ownership of lands.”¹ He also coauthored a letter encouraging then-Speaker Boehner to expand federal fossil fuel production and to sell public lands as deficit-reduction measures, claiming “most of it we do not even need.”² In 2016, he cosponsored the HEARD Act, a bill which directed agencies to sell or exchange public lands.³ And in 2017, he was an outspoken proponent of Trump shrinking and slashing the Organ Mountains-Desert Peaks, Bears Ears, and Grand Staircase-Escalante National Monuments.⁴ Mr. Pearce's persistent calls for the privatization of public lands are alarming, especially for the millions of Americans who mere months ago witnessed—and emphatically opposed—the sell-off attempt in the reconciliation package.

Has Encouraged Extremist Actions and Illegal Activity

Mr. Pearce has a disturbing history of encouraging vigilante sentiment and activity in order to seize control of federal public lands and undercut faith in government and democracy. In 2011—as a sitting congressman—Mr. Pearce participated in an event where protesters planned to illegally cut down trees in New Mexico's Lincoln National Forest in defiance of federal rules; the action was ultimately covered by permits granted just days before the event.⁵ That same year,

Mr. Pearce urged the crowd at a town hall to “take control” of public lands.⁶ Mr. Pearce also led rallies opposing protections for other wildlife like the dunes sagebrush lizard and lesser prairie chicken, and sought to delist the Mexican gray wolf and defund its recovery.⁷

In 2014, scofflaw Nevada rancher Cliven Bundy orchestrated an 11-day armed confrontation against law enforcement using the threat of mass violence to defend his illegal, and still ongoing, grazing and degradation of BLM lands.⁸ Later in 2016, when armed militants led by Ammon Bundy (Cliven’s son) occupied the Malheur National Wildlife Refuge in Oregon, Mr. Pearce did not condemn their cause; in fact, he defended Dwight and Steven Hammond, the ranchers whose arson convictions sparked the occupation.⁹ Consequently, the Hammonds served prison time and had their grazing permits revoked—but the decision as to whether or not to reissue the grazing permits would fall to none other than Mr. Pearce if he is confirmed.¹⁰

These so-called “Sagebrush Rebellion” standoffs helped set the stage for far-right, anti-government, “Patriot” movement groups such as the Three Percenters and Oath Keepers—major players in the Bundy standoffs—to build power and perceived social license in the years to follow.¹¹ These groups were instrumental in the January 6, 2021 Capitol riot.¹²

Mr. Pearce’s predecessor, Ms. Kathleen Sgamma, withdrew her nomination after her criticism of President Trump’s response to the January 6, 2021 Capitol riot had come to light.¹³ In stark contrast, Mr. Pearce aired conspiracy theories about the election and tweeted (in a now-deleted post) just days after the Capitol attack that President Trump “will be our President FOREVER.”¹⁴ President Trump allowed a chain of temporary appointees to fill the role of BLM Director during his first term;¹⁵ but now, if confirmed, Mr. Pearce has shown that he is willing to play an unwavering part of President Trump’s anti-environmental and anti-democratic agenda by heeding unpopular directives, propping up polluters, and selling off and selling out our public lands.

Will Serve the Oil and Gas Industry Rather than the People and Lands

As a lawmaker, Mr. Pearce sought to use public lands to enrich the fossil fuel industry—and himself. Mr. Pearce was a longtime owner of an oilfield services company and maintained holdings in oil-related companies while serving in the U.S. House of Representatives.¹⁶ Mr. Pearce has taken more than \$2 million in political donations from the oil and gas industry,

roughly 3 times as much as the next special interest.¹⁷ His congressional record is so devoid of support for basic environmental protections that his votes have yielded him a 4% lifetime score from the League of Conservation Voters.¹⁸

Mr. Pearce flagrantly has not merited the honor of stewarding the lands that have been entrusted to present and future generations of Americans. We urge you to oppose his confirmation.
