In response, each Defendant submitted a declaration on October 17, 2025. See ECF Nos. 62; 62-1 through -34; 66; 66-1; 67; 67-1.

On October 17, 2025, the Court entered a modified TRO and ordered that "by 9:00 a.m. Pacific time on Monday, October 20, 2025, Defendants shall file the 'accounting of all RIFs actual or imminent, that are enjoined by this TRO,' consistent with the clarifications and modification herein, including by providing agency declarations that identify any RIFs that have been or are being planned or prepared to be issued during the federal government shutdown, and including the information required to be included by the provisions of the October 15, 2025 TRO ('a description of the agency . . . , the number of employees included in the enjoined RIF, and description of the PPAs that Defendants included in the enjoined RIF')." ECF 70 at 4 (ellipsis in original). In response, Defendants hereby submit the attached supplemental declarations from three of the Defendant agencies. Pursuant to 28 U.S.C. § 1746, I, Crystal Taylor, declare as follows:

- I am the Acting Chief Human Capital Officer and Director, Office of Human Resources Management at the Department of Commerce (Commerce), headquartered in Washington, D.C. I have served in this position since September 25, 2025.
- In my role at Commerce, I am responsible for personnel management. I have the
 responsibility for tracking and recording personnel actions, including Reductions-inForce (RIFs). I assist in ensuring that all personnel actions comply with court orders
 and federal law.
- 3. I am aware of and have reviewed the following orders issued by the Court in this action:
 - a. The October 15, 2025 Temporary Restraining Order (TRO); and
 - b. The October 17, 2025 Order Clarifying Temporary Restraining Order and Granting Plaintiffs' Motion to Modify (Modified TRO).
- 4. I understand that under the Modified TRO, the entities benefited by the TRO now include five national unions—AFGE, AFSCME, NFFE, SEIU, and NAGE—and two local California-based chapters, AFGE Local 1236 and AFGE Local 3172. Together, these seven entities are referred to below as "Plaintiffs."
- 5. I also understand that, among other things, the Modified TRO provides definitions of terms used in the original October 15 TRO.
- 6. The Modified TRO requires Defendants to file, by 9:00 a.m. Pacific time on October 20, 2025, "the 'accounting of all RIFs actual or imminent, that are enjoined by this TRO,' consistent with the clarifications and modification herein, including by providing agency declarations that identify any RIFs that have been or are being

- 7. I make this supplemental declaration to update certain information in my declaration of October 17, 2025, in response to the Modified TRO.
- 8. As stated in my declaration of October 17, 2025:
 - a. Between October 1 and October 14, 2025, Commerce issued specific 60-day RIF notices to 281 people informing them that their positions would be abolished and they would be separated at the conclusion of the 60-day period.¹
 - b. Between October 1 and 15, 2025, Commerce issued general RIF notices to 159 people informing them that Commerce was conducting a RIF, there was a possibility of separation as a result of the RIF, and they would be provided specific notice in the future if it was determined that they would be part of the RIF.
- 9. At present, there are two bureaus with employees represented by Plaintiffs at which Commerce has issued RIF notices.
- 10. First, as stated in my declaration of October 17, 2025, the U.S. Census Bureau, which has employees represented by AFGE, issued 108 RIF notices. The actual number of impacted employees is 102, as the U.S. Census Bureau erroneously sent out notices to six individuals who had recently separated from the agency. The PPAs involved are:
 (a) Current Surveys and Programs; and (b) Periodic Censuses and Programs.

¹ On Friday, October 17, 2025, Commerce reported that it had issued specific 60-day RIF notices to 282 people. The correct number is 281 as updated in this supplemental declaration.

11. Second, the Minority Business Development Agency (MBDA), which has employees represented by NFFE and is subject to the Modified TRO, has issued 23 RIF notices. The PPA involved is Minority Business Development.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.

Pursuant to 28 U.S.C. § 1746, I, Rachel Borra, declare, pursuant to 28 U.S.C. § 1746, as follows:

- 1. I am the Chief Human Capital Officer at the U.S. Department of Interior, headquartered in Washington, D.C. I have served in this position since September 29, 2025.
- 2. In my role at Interior, I am responsible for personnel management. I have the responsibility for tracking and recording personnel actions, including Reductions-in-Force (RIFs). I assist in ensuring that all personnel actions comply with court orders and federal law.
- 3. I make this declaration, and the preceding October 17, 2025 declaration and October 17, 2025 supplemental declaration, based on my own personal knowledge, on information contained in the records of the Department, or on information provided to me by Department employees.
- 4. Plaintiffs in this lawsuit include two national unions, AFGE and AFSCME, and two local California-based chapters, AFGE Local 1236 and AFGE Local 3172.
- 5. I am aware of and have reviewed the October 15, 2025, temporary restraining order (TRO) and the October 17, 2025 Order (Modified TRO) issued by the Court in this action.
- 6. I make this declaration in response to the Modified TRO, which granted Plaintiffs temporary injunctive relief and restrained Defendants from taking certain actions related to RIFs.
- 7. The Court's Order required Defendants to report certain information by 9:00 a.m. PDT on October 20, 2025, requiring Defendants to serve and file:

"the accounting of all RIFs, actual or imminent, that are enjoined by this TRO," consistent with the clarifications and modification herein, including by providing agency declarations that identify any RIFs that have been or are being planned or prepared to be issued during the federal government shutdown, and including the information required to be included by the provisions of the October 15, 2025 TRO ("a description of the agency ..., the number of employees included in the enjoined RIF, and description of the PPAs that Defendants included in the enjoined RIF").

- 8. The Court's Order also granted plaintiffs' motion to extend the relief granted to National Federal of Federal Employees ("NFFE"), Service Employees International Union ("SEIU"), and National Association of Government Employees ("NAGE").
- 9. I previously submitted a declaration and supplemental declaration on October 17, 2025, stating that Interior had intended on imminently abolishing positions in 68 competitive areas that include members and bargaining unit employees of the plaintiffs at that time, and that:
 - a. These 68 competitive areas included 9,943 employees;
 - b. Of these 9,943 employees, 2,567 are employees covered by Plaintiffs;
 - c. Within the 68 competitive areas, Interior intended to abolish 1,539 positions.
- 10. Given the Court's October 17, 2025 Order extending the TRO to NFFE, SEIU, and NAGE, I further state that, including NFFE, SEIU, NAGE, and the plaintiffs contemplated in paragraph 4 above, Interior had intended on imminently abolishing positions in 89 competitive areas that include members and bargaining unit employees of the plaintiffs (a term that, for purposes of this declaration, includes NFFE, SEIU, and NAGE) at this time. Further,
 - a. These 89 competitive areas included 14,212 employees;
 - b. Of these 14,212 employees, 4,833 are employees covered by Plaintiffs (including NFFE, SEIU, and NAGE);

- c. Within the 89 competitive areas, Interior intended to abolish 2,050 positions.
- d. To be clear, the 89 competitive areas are inclusive of the 68 competitive areas disclosed in my previously submitted October 17, 2025 declaration.
- 11. In compliance with the October 17, 2025 Order, I submit the attached descriptions of the 89 competitive areas disclosed in paragraph 10 above. See Appendix A, Brief Description of Competitive Areas that Include Members or Bargaining Units of Plaintiffs.
- 12. As previously declared, any RIFs contemplated or planned by Interior predated the October 1, 2025 lapse in appropriations and were in no way motivated by or pursuant to the September 24, 2025 Office of Management and Budget or September 28, 2025 Office of Personnel Management guidance on RIFs during a lapse in appropriations.
- 13. As stated in my prior declaration, Interior has stopped work on RIF notices for competitive areas that include bargaining unit members represented by Plaintiffs as defined in the October 17, 2025 Order, and it will not proceed with any RIFs for competitive areas that include bargaining unit members represented by Plaintiffs as defined in the October 17, 2025 Order for as long as the TRO remains in force, absent an order from a higher court providing relief.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.

I, Thomas J. Nagy Jr., declare as follows pursuant to 28 U.S.C. § 1746:

Case 3:25-cv-08302-SI

- I am the Deputy Assistant Secretary for Human Resources/Chief Human Capital
 Officer at the U.S. Department of Health and Human Services (HHS), headquartered in
 Washington, DC. I have served in this position since March 27, 2025.
- 2. In my role at HHS, I am responsible for personnel management. I have the responsibility for overseeing the tracking and recording of personnel actions, including Reductions-in-Force (RIFs). I assist in ensuring that all personnel actions comply with court orders and federal law.
- 3. I am aware of and have reviewed the October 15, 2025, temporary restraining order (TRO) issued by the Court in this action, as well as the October 17, 2025, modified TRO. I make this declaration to update certain information in my previous declaration, in response to the Court's order to file an "accounting of all RIFs actual or imminent, that are enjoined by" the TRO as modified.
- 4. On October 10, 2025, HHS issued 954 RIF notices, not inclusive of those that have since been rescinded, to employees in certain competitive areas within certain HHS Operating and Staff Divisions. I have noted in the attached chart the specific number of RIF notices the agency sent out in competitive areas containing any bargaining unit or member represented by any Plaintiff. The competitive areas included in the attached chart contain employees with AFGE bargaining units² or members.
- 5. HHS will not proceed with any RIFs prohibited by the TRO for as long as the TRO remains in force, absent an order from a higher court providing relief.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.

¹ Since filing my declaration of October 17, 2025, I have become aware that HHS has rescinded additional RIF notices, bringing the number of current RIF notices down to 954.

² As stated in my declaration of October 17, 2025, CDC had AFGE bargaining units until August 26, 2025, when the relevant Collective Bargaining Agreements were terminated pursuant to Executive Order 14251, Exclusions from Federal Labor-Management Relations Programs.
